Decentralization election officials and staff training

Context



During the 11th Diaspora Development Dialogue (DDD), entitled "Global Compact: Breaking the Barriers", that took place in Barcelona in 2019, the Mayor of Lagbar found the presentation of CBINN's goals extremely relevant and useful, and asked the organization to conduct a training. This is how, with the combined effect of the DDD and ADEPT's Seed Funding program, the project 'Decentralization election officials and staff training' was launched.

CBINN is a non-profit organization that aims at improving the living conditions of women and children of marginalized communities from the African diaspora. To achieve its objectives, CBINN works in partnership with municipalities and local/grassroot organizations to participate inthe political and decision-making processes and to implement concrete programs aiming at fostering thesocial and economic development by setting up quality sub-systems. In addition, CBINN specializes in village development in order to lift women, girls and young people out of poverty through empowerment programs which objective is to generate income and promote autonomy and self-determination.

In 2012, the State of Senegal drew up Act 3 of the Decentralization Policy with full communalization, the establishment of departments into local authorities and the development of territorial poles. This reform has involved the training of local elected officials in order to achieve an inclusive and participatory territorial development, and justifies this training action in the same manneras the planetary intentions of sustainable development oriented towards viable, sustainable and self-managed cities.

This action was carried out in the municipality of Labgar in the Republic of Senegal and focused on participatory governance and decentralization. More than half of the participants were women.

The training action targeted the municipality of Labgar, which, because of its rural status, is one of the most vulnerable municipalities in Senegal.

Activities

The training lasted 5 days and targeted local elected officials and municipal staff.

The participants were trained on the selected themes/topics in the form of workshops over a period of 40 hours, using the Poular language for a better understanding of the participants.

The training was taught according to the following principles: An active and participatory approach, at the heart of the training action, in order to promote an inclusive acquisition of skills, that takes into account the profile and level of knowledge of the participants

- A facilitating approach resorting to practical applications, case studies, group work, role-plays and content analyses.

Outcomes

Different themes were identified for the capacity building sessions of the Municipal Council

- Good governance at the municipal level, to increase the performance of some of the activities thanks to the transfer of competences, in compliance with the law
- Financial questions, to help balance the budget with revenue collection, expenditure rationalization, community resource mobilization and increased social services and programs
- Citizen participation, as one of the conditions for the establishment of the participatory budget involving the citizens in Council meetings
- Awareness raising activities for the citizens, in order to promote their participation in the development effort
- The importance of basic social services and the promotion of local economic development
- The improvement of the functioning and the organization of the local civil service, by reviewing and improving its bodies, its committees and the staff
- The importance of holding Municipal Council meetings and Committee meetings
- The system of transmission and archiving of administrative documents.
